



CEE Faculty Sponsor Cheat Sheet for Burges Visiting Professors

Non US Citizens and non green card holders

All international Burges visiting professors can request travel reimbursement and / or honorarium, regardless of visit length and whether salary is requested as well. The visa timeline indicates the minimum time prior to the visit that is required to apply for and process a visa.

Unless otherwise noted, all Burges visiting professors can request travel reimbursement and / or honorarium, regardless of visit length and whether salary is requested as well. No visa or additional work authorization is required.

		<p>Assistant/Associate/Professor (Rank commensurate with home institution; CEE faculty vote + board approval required)</p> <p>Key notes: Combined salary paid by UW and visitor's home institution must meet UW salary minimum. If visitor serves as instructor of record, then start and end dates must align with academic year or quarter. <i>Not eligible for travel reimbursement or honorarium.</i></p>

Key Reminders

- **Titles:** CEE Faculty sponsors should inform applicants that during the visitor’s time at the UW, they will be acknowledged with the distinction of Visiting Burges Professors, however, they will be assigned an official UW academic personnel title that aligns with the nature of their visit activities and/or the requirements of their visa status.
- **Honorariums** may only be processed for academic events like lectures, colloquiums, and public presentations.
- **Tax Requirements:** Non-U.S. citizens **must** have an approved visa to receive compensation and pay appropriate taxes.
- **Citizenship Disclosure:** Applicants with U.S. citizenship or green cards should disclose their status to their CEE faculty sponsor and in their application for a streamlined process.
- **Cross-Institution Visits:** Non-U.S. citizens visiting another U.S. institution should confirm that their work authorization allows a visit to UW.
- **ESTA Program/B-1 or B-2 Tourist Visas:** The applicant should be aware that they need to apply for these visas (UW doesn’t play a role in this process), but CEE will refund the application fee.
